Official Contest Rules

(Effective September 17, 2018)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

1. **CONTEST PERIOD:** Begins August 19, 2019 and ends on September 30, 2018 [HST] (“Contest Period”).
