

Letters to Santa 2020 Campaign

Official Rules

(Effective November 2, 2020)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

1. **ENTRY PERIOD:** Begins November 2, 2020 and ends on November 15, 2020 [HST] (“Contest Period”).
2. **HOW TO ENTER:** During the Entry Period, participants are to write or draw a letter to Santa and include his or her holiday wishes. Letters are to be placed into the entry box located at all participating Seven-Eleven Hawaii, Inc. (“Sponsor”) stores or digitally submitted via www.7ElevenHawaii.com.
